Eligibility

 - ▶ A candidate should have completed graduation while attempting CFA Level 2 examination
 - ▶ A Valid International Passport
- OR
- ▶ Candidates should have a minimum work experience of 4000 Hours or a combination of 4000 hours of work experience or higher education acquired over a minimum period of 3 sequential years before registering for level 1 exam.

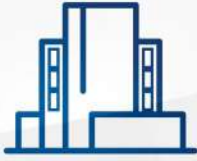
