## PROGRAM **STRUCTURE**

- 01 | FPA in association with ISDC Learning who has partnered with universities globally, will provide hybrid UG PG programs. For the UG, the first 2 years would be in India, and the 3<sup>rd</sup> one will be abroad.
- 02 | The first year will give a SCQF (Scottish Credit and Qualifications Framework) Level 7 International Certificate in Business, helps develop key management skills. Post completion progress to SCQF Level 8, International Specialised Diploma in Business Management.
- 03 | Level 8 allows learners to study core subjects of Business Management along with their choice of specialization. So there are three core modules and then students can choose any one of the eight career-focused pathways in accordance with their interests & aspirations which will have 4 specialist modules.
- 04 | In total learners complete 6 modules in Level 7, and 7 modules in Level 8 in order to successfully complete integrated ISDC's Qualification. Post this students move abroad to university of their choice where they complete the final year and get the degree from that university. Post which you apply for work visa and be eligible to stay in the country for another 2 years.
